1. Description of Contest/Participation.

A. Dates of Contest: The Contest will begin on April 1, 2019 and end on October 7, 2019.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

B. How to Win:

a. Participants must locate "Mr. Red" hidden on wrbiradio.com. To enter, participants need to click on the "Mr. Red" graphic and then complete the form as indicated. WRBI is not responsible for any technical difficulties experienced in accessing the internet, or wrbiradio.com or any other factor that may prevent an individual from gaining access to wrbiradio.com. In the event of an interruption of power or internet service at our website hosting facility, the contest will resume once power or service has been restored. One entry per person, per week.

b. For each week, all correct entries will be placed in a random drawing to determine that week's winner. Winner will be announced on the following Monday between 7:00 AM and 8:00 AM EDT. The first winner will be announced Monday, April 8, 2019. In weeks where Monday is a nationally recognized holiday, the winner will be announced on Tuesday between 7:00 AM and 8:00 AM EDT.

c. The weekly contest for weekly prizes runs from Saturday to the following Friday. "Mr. Red" will change locations on wrbiradio.com each weekend during the contest. The final week winner and month winner will be announced on Monday, October 7, 2019 between 7:00 AM and 8:00 AM EDT. The grand prize winner decided from a random drawing of all entries of the Where "Mr. Red" contest and all entries from all of WRBI summer promotions on Friday, October 11, 2019, between 7:00 AM and 8:00 AM EDT.

C. Multiple Entries: Only one entry per person per week. Multiple entries per week are prohibited and void all entries for that week.

2. Prize(s). The prize(s) that may be awarded to the eligible winner(s) are:

If a winner cannot be contacted or is disqualified, the Company reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

3. Eligibility and Limitations. Participants and winner(s) must be U.S. residents at least 18-years old as determined by the Company and reside in the Station's Total Survey Area (TSA). Only one (1) prize per person from any of the Company's stations within any 14-day period. All Where's Rosie Red participants whether or not they've won a prize within 14-days are eligible for the grand prize drawing. Employees of the Company, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. Station(s) shall follow the applicable laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the Contest, etc. as required by local and state law.
