1. Description of Contest/Participation.

A. Dates of Contest: Contest will begin on the October 1, 2020 and run through January 10, 2021.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.

B. How to Enter: Use the form on the WRBI web site "wrbiradio.com" to submit a picture of you and your trophy deer by January 10, 2021.

- Must be at least 18 years old to enter.
- Photo must include yourself and your deer.
- Deer must have been killed this season.
- One entry per person.

Deer must have been killed legally, pursuant to Indiana DNR laws, rules, and regulations.

C. How to Play: One winner will be determined, by a panel of WRBI judges, after contest entry closes.

2. Prize(s). The prize that may be awarded to the eligible winner will be:

- A Prize of \$100.00 Cash will be awarded to the winner to be announced on January 15th, 2021 at or around 8:40 AM.

3. Eligibility and Limitations. Participants and winner(s) must be U.S. residents at least 18-years old as determined by the Company and reside in the Station's Total Survey Area (TSA). Only one (1) prize per person within any two-week period. Employees of the Company, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

4. Publicity; Use of Personal Information. By participating, where allowed by law, all participants and winner(s) grant the Company exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with promotion of this and other contests and waive any claims to royalty, right, or remuneration for such use. 5. Release.
