1. Description of Contest/Participation.

- A. Dates of Contest: Contest will begin on June 14, 2021 at 6:00 AM EDT and end on June 21, 2021 at 12:00 AM EDT. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.
- B. How to Enter: Register online at WRBIRadio.com starting June 14, 2021 and before 12:00 AM EDT on June 21, 2021.
- C. How to Play: One winner will be randomly selected from entries after the contest closes on June 21, 2021 at 12:00 AM EDT and announced between 7:00 AM EDT and 8:00 AM EDT on Monday, June 21, 2021.

2. Prize(s). The prize that may be awarded to the eligible winner will be:
