- B. How to Enter: Register online at WRBIRadio.com starting Saturday, June 1, 2024 and before 11:59 PM EDT on Sunday, June 16, 2024.
- C. How to Play: One winner will be randomly selected from entries after the contest closes on Sunday, June 16, 2024 at 11:59 PM EDT and announced during The Morning Show on Monday, June 17, 2024.
